Amendment to Handbook of Procedures 2023 Affects SCOMET Authorization Process

In a recent update to the Handbook of Procedures (HBP) 2023, the Directorate General of Foreign Trade (DGFT) has amended Para 10.06(III) concerning the delegation of powers for the approval of authorizations under the SCOMET (Special Chemicals, Organisms, Materials, Equipment, and Technologies) framework.

Effective immediately, the amendment introduces changes to the approval process when comments, views, or NOCs (No Objection Certificates) from all relevant agencies are received with no conflicting opinions. Under the revised guidelines, if a case has been deferred in the Inter Ministerial Working Group (IMWG) meeting, and there are no divergent views from the concerned agencies, the authorization can now be issued with the approval of the Chairman of IMWG or an officer nominated by the Chairman/DGFT, who must be of a rank not lower than Deputy Director General of Foreign Trade or Under Secretary. The case will then be presented to the IMWG at its next meeting for ex-post facto approval.

This amendment streamlines the process, aiming to expedite authorization while maintaining oversight through subsequent IMWG meetings.

Board to Address GST Cases with Multiple Interpretations Under New Guidelines

The Central Board of Indirect Taxes and Customs (CBIC) has issued Instruction No. 03/2024-GST dated August 14, 2024, providing updated guidelines on handling GST cases involving multiple interpretations. This instruction builds upon the Board's earlier guidelines outlined in Instruction No. 01/2023-24-GST (Inv.) dated March 30, 2024.

According to Para 2(g) of the previous instruction, situations may arise where a CGST Zone's investigation, led by a Principal Commissioner, might propose non-payment or short payment of tax. This is typically based on one interpretation of the CGST Act, rules, notifications, or circulars, while the taxpayer follows a prevalent trade practice based on a different interpretation within the industry. Such scenarios can lead to multiple interpretations and potential litigation.

To address this, the new instruction directs that if such scenarios are identified during an audit, the Zonal Principal Chief Commissioner should make a self-contained reference to the GST Policy or TRU wing of the Board. This should be done as early as possible, ideally before issuing a show cause notice, to ensure uniformity and potentially avoid litigation. The matter may also be reviewed by the GST Council if necessary.

This updated procedure aims to streamline the audit process and promote consistency in GST enforcement, while also accommodating ongoing audit proceedings.

DGFT Enhances eBRC Self-Certification Process with New Features

The Directorate General of Foreign Trade (DGFT) has announced significant upgrades to its electronic Bank Realisation Certificate (eBRC) system through Trade Notice No. 12/2024-25 dated August 14, 2024. Building on the pilot phase introduced under Trade Notice No. 33/2023-24, the DGFT is enhancing its eBRC process to further streamline export realizations.



Effective August 20, 2024, two new functionalities will be introduced:

- 1.Bulk Upload: Exporters can now generate multiple eBRCs simultaneously using the new bulk upload feature. By submitting a spreadsheet containing Inward Remittance Message (IRM) mappings along with Shipping Bill and Invoice details, exporters can automate the certification process for numerous eBRCs. This functionality aims to improve efficiency, reduce manual errors, and simplify the management of self-certification documentation.
- 2. API Integration: The new API integration allows exporters to connect their Enterprise Resource Planning(ERP) or accounting systems directly with the DGFT eBRC system. This integration facilitates real-time retrieval of IRM/ORM data and enables the automated request and verification of eBRCs. Exporters must complete an online registration process and manage API access, including activation and deactivation, to ensure secure and efficient operations.

For additional guidance, user manuals are available on the DGFT website under the 'Learn' section. The DGFT Regional Authorities will also conduct Exporter Outreach Programs to demonstrate the new eBRC capabilities. Stakeholders are invited to provide feedback via email at ebrc-dgft@gov.in.

This initiative reflects DGFT's commitment to enhancing operational efficiency, reducing complexity, and improving the ease of doing business for exporters.

India's Electronic Goods Exports Surge in July 2024, Driven by Mobile Phone Exports

India's export sector has shown remarkable growth, with electronic goods leading the way. In July 2024, the country's total exports are estimated to increase by 2.81%, continuing a positive trend. Over the April-July 2024 period, cumulative exports are projected to grow by 6.65%, underscoring strong trade performance.

A key contributor to this growth is the surge in electronic goods exports, which jumped by 37.31% in July 2024, reaching USD 2.81 billion compared to USD 2.04 billion in July 2023. A significant portion of this growth was driven by mobile phone exports, which, according to industry estimates, accounted for USD 1.602 billion.

The cumulative value of merchandise exports from April to July 2024 totalled USD 144.12 billion, up from USD 138.39 billion in the same period last year, marking a 4.15% increase. Non-petroleum and non-gems & jewellery exports also saw a positive rise of 5.69%, growing from USD 25.47 billion in July 2023 to USD 26.92 billion in July 2024.

The robust performance of electronic goods, particularly mobile phone exports, along with growth in other key sectors such as engineering goods, pharmaceuticals, and textiles, highlights India's strengthening position in global trade.
